TO ALL PERSONS HAVING CLAIMS, DISPUTES OR DEMANDS AGAINST THE ABOVE ECCLESIASTICAL JURISDICTION AND ALL OTHER PERSONS INTERESTED IN THE CHURCH OR OTHER PERSONS HAVING CONDUCTED ECCLESIASTICAL CHURCH BUSINESS HAVING AN INTEREST IN OR AFFECTED BY SAME. .

YOU ARE HEREBY NOTIFIED that the administration of the above-referenced ecclesiastical jurisdiction represented by its Primate, Archbishop Haralambos Bouchlas, duly authorized by his predecessor Metropolitan Nicolas Unisky, now deceased, gives notice and legal disclaimer to any business conducted or legal documents not having his written authorization bearing his name, signature and his seal.

Whereupon this jurisdiction conducts its secular business, owns real property, disburses monetary funds, receives donations, and obtains monetary loans under Florida law, has its own IRS tax ID number, is incorporated and known as St. Michael Evangelical Orthodox Church, Inc., and The Patriarchato Labydonos New Jerusalem Independent, Inc. Metropolitan Archbishop Haralambos Bouchlas a/k/a Robert Bouchlas serves as Chairman of the Board and Director of the above Florida corporations. Duly appointed board of directors, according to the uniform by-laws of the ecclesiastical jurisdiction as well as the recorded by-laws of the above-named corporations with the Secretary of State of Florida serve both corporations.

All other ecclesiastical jurisdictions bearing the same above-referenced name, Holy Ukrainian Autocephalic Church in Exile, or any similarity thereof, have no vested interest in the above named corporations, or its assets. The above-referenced corporations have no legal fiduciary responsibility and hereby disclaims supervision of its clergymen. This concerns any Ukrainian jurisdiction either in America or Europe.

St. Michael Academy of Eschatology, a registered Florida Bible College and its Board of Directors are not necessarily one and the same persons serving the above corporations. The college is under the jurisdiction of the Greek Pan Orthodox Archdiocese only.

It is hereby noted there are church records signed by Metropolitan Nicolas Ilnisky dated from May 1, 1992 to October 26, 1997, excommunicating Paul W. Seese, Paul Mark Harteis, Michael D. Kirkland, and Joseph M. Ande (Ande issue is in dispute and under review, therefore he is presently in communion). Archimandrite Dionysios Edmunds' excommunication is also under review, and he is not in communion with the above referenced jurisdiction. Lloyd W. Haney, Jr., Oilie D. Hollis, and Mark Stewart were subsequently suspended by Metropolitan Archbishop Haralambos on August 9, 1999.

All persons having claims, dispute or demands against the jurisdiction are required, within one month from the date of the first publication of this notice, to file with the administrative office at 4414 Washington Road, West Palm Beach, FL 33405, a written statement of any claim or demand they may have. Each claim must be in writing and must indicate the basis of the claim with their name and address.
